



### Cold Lake Fire-Rescue 2018 Fire Stats by Month

### COLD LAKE RCMP DETACHMENT & COLD LAKE VICTIM SERVICES SOCIETY 2018 YEAR END REPORT

### **COLD LAKE RCMP**

The Royal Canadian Mounted Police at Cold Lake currently has a detachment strength of 36 personnel. The Detachment is comprised of 1 Staff Sergeant, 1 Sergeant, 4 Corporals, 21 Constables, and 9 Detachment Clerks (6 Municipal Employees and 3 Public Service Employees). The detachment area is geographically large and diverse with policing responsibilities for the City of Cold Lake, the eastern portion of the MD of Bonnyville, the Cold Lake First Nations and the Elizabeth Métis Settlement.

The RCMP at Cold Lake provides 24-hour policing services every day of the year. Having RCMP Members available at all times promotes better service delivery and more timely response to calls for service. Cold Lake Detachment has 3 separate watches of Constables who work under the direction of a Corporal supervisor. These 3 Watch supervisors, the General Investigation Section (GIS) Corporal and the Police Dog Service report to the Sergeant Operations NCO, who reports to the Staff Sergeant Detachment Commander. The Staff Sergeant reports to the Chief Superintendent in charge of Eastern Alberta District (EAD) located in St. Paul.

Based on PROS data, Cold Lake generated at total of 8823 files in 2018; a decrease of 70 files or .8% when compared to 8893 files generated in 2017. The Cold Lake Municipal generated 5,587 files a 3.8% 210 file decrease when compared to 5,697 files generated in 2017. The Cold Lake Provincial generated 3,336 files, a 4.4% 140 file increase when compared to 3196 files generated in 2017.

In 2018, the General Investigations Section (GIS) investigated organized crime, specifically the trafficking of illegal drugs. Numerous charges were laid and some are pending further investigation. The unit also assisted with the targeting of prolific offenders by conducting surveillance on known perpetrators heavily involved in drug use and stolen property. The GIS team contributes by building partnerships with the Edmonton Major Crimes Unit, EAD Crime Reduction Unit, Social Development agencies, Corrections, Probation, the MD of Bonnyville and City Peace Officers, all with a view to better serve our community. The team is focused on gathering this intelligence from numerous sources within the community which include but are not limited to: general interactions with the public, anonymous tips from the public, active confidential informant recruitment and inter-agency sharing of information.

The Police Dog Unit started with the Cold Lake Detachment on May 17, 2018. The Unit has been instrumental in apprehending numerous suspects. By the end of 2018 the handler and his dog, Harp, were directly involved in a total of 189 files: 97 within Cold Lake and 92 outside the Cold Lake area. They captured 62 persons: 33 within Cold Lake and 29 outside the City Limits.

For the 2018 calendar year, 1,206 prisoners were held in Cold Lake Detachment cells, compared to 1,280 prisoners in 2017, this is a decrease of 74 prisoners and a decrease in prisoner count volume of 6%.

The Cold Lake RCMP Detachment is broken down into the following contracts (a "contract" indicates different funding sources or funding structures):

#### **Provincial Policing**

#### MD of Bonnyville (Eastern portion), Cold Lake First Nations, and Elizabeth Métis Settlement:

10 RCMP Members, comprised of 1 Staff Sergeant, 2 Corporals and 7 Constables. One of the 7 Constables is committed to the General Investigation Section (GIS) as a developmental secondment and 1 Constable is committed to the Elizabeth Metis Settlement under an Enhanced Agreement, as noted below.

#### **Municipal Policing**

### City of Cold Lake:

17 RCMP Members, comprised of 1 Sergeant, 2 Corporals, and 14 Constables. This includes: The General Investigation Section, made up of 1 Corporal and 1 Constable; and the Police Service Dog Master and his K9 partner.

#### **First Nations Policing**

#### Cold Lake First Nations and Elizabeth Métis Settlement:

There are currently no Enhanced Policing Agreement positions on the Cold Lake First Nations. However, we have recently designated 1 of the Provincially funded Corporals as the Indigenous Policing Liaison. This member supervises the Elizabeth Métis Settlement Enhanced Constable and works closely with Cold Lake First Nations and Elizabeth Métis Settlement to enhance working relationships, form partnerships, and implement community programming. 1 Constable is assigned solely to the Elizabeth Métis Settlement (1 of the 10 Provincial positions).

#### **Support Staff for all Contracts**

9 Support Staff are responsible for assisting members, receiving complaints from the public and keeping the office running smoothly. The Support Staff are comprised of 3 Federal Public Service Employees that includes 1 Office Manager and 2 Detachment Services Assistants, 6 Municipal Support Staff Employees which include 3 Watch Clerks, 2 Detachment Clerks, and 1 Operational/Training Clerk (newly implemented late 2018).

#### **STAFFING**

There were 5 transfers from the Cold Lake Detachment in 2018. The 5 Members transferred away this year were Staff Sergeant Jeremie Landry, and Constables Jody Mattinson, Anastasia Fedorova, James Miller, and Caroline Jones. "K" Division RCMP Staffing and Personnel have been doing a good job filling the positions as required. There have been 6 transfers to the Detachment in 2018; Detachment Commander Staff Sergeant Scott Buchanan, Corporal Marie-Eve Mackenzie-Plant in charge of the General Investigation Unit and Constable Jason Jaques with the Police Dog Service. We also received three newly appointed Constables; Jessi Sharma, Ryan Baillie and Thomas Harris. There were 6 maternity and paternity leaves during 2018 along with some cases of extended medical leave.

We had 2 Municipal Detachment Clerks join our team in 2018; Doryn Cross and Lorine Hinse (who filled the new Detachment Clerk position provided from funding by the MD of Bonnyville). A Public Service

Detachment Services Assistant went on maternity leave in December; this position has been back-filled and the new hire will start on the completion of their security clearance (expected to be this Spring).

### **2018 ANNUAL HIGHLIGHTS**

- November, 2018 Cold Lake RCMP conducted a Candy Cane check stop with Cold Lake VSU in the City of Cold Lake.
- December, 2018 Pack the PC fund-raiser was held for Cold Lake Food Bank and Cold Lake Victim Services with Cold Lake RCMP, Military Police, Cold Lake Peace Officers and Fish and Wildlife.

 December, 2018 - Cold Lake RCMP and Cold Lake VSU delivered a Drug Awareness presentation at the Le Goff School on CLFN.

The members of the Cold Lake Detachment have been, and continue to be, visible in the Community working with our various partner agencies. Our involvement included, but is not limited to school visits/presentations, joint patrols/presentations with City and MD Peace Officers, Community Group presentations, Operation Red Nose, Charity Hockey Game with Cold Lake Fire Rescue, Cold Lake Search and Rescue Society and Community Response to Elder Abuse Team (CREAT).

### **POLICING PRIORITIES**

Each year the Cold Lake RCMP prepares an Annual Performance Plan. These plans are prepared through consultation with elected officials and community groups representing the entire area policed by the Cold Lake Detachment. This plan is a yearly document; however, it is managed on the RCMP fiscal year which is from April 1, 2018 to March 31, 2019. Below are some of the year to date (YTD) third quarter results for this annual planning document (ie. *this reflects % of the 2018/19 year*).

#### **COLD LAKE VICTIM SERVICES SOCIETY**

Cold Lake Victim Services is proud that we have been serving the community of Cold Lake and area for 27 years. Assisting those impacted by crime or tragedy in our community. Cold Lake VSU once again had a record breaking amount of referrals with 1078 files in 2018. Cold Lake VSU seeks to ensure that our clients work towards a state of well-being after experiencing a crime or tragedy.

Cold Lake Victim Services is a not for profit organization, which operates under the guidance of the RCMP. Our Program consists of an RCMP and a Military Liaison Officer, a volunteer Board of Directors, a group of volunteer advocates and three staff members. Cold Lake Victim Services helps people through difficult times. Under the guidance and direction of the Cold Lake RCMP, we provide support, information, and referral services to crime/tragedy victims and their families. Our services are available on a 24-hour basis, they are free and confidential.

We also provide resource material and information on crime information as well as Alberta Justice and Solicitor General – Victims Programs, such as the Financial Benefits, the Victim Impact Statement and the Request for Restitution. Another important aspect of the victim service program is assisting victims going through the Judicial System. Many victims of crime have never been inside a court house. This can be a confusing and traumatic experience which can go on for many months or even years. Trained victim service advocates offer court preparation, court support and keep victims up to date on court proceedings.

A very important piece of victim service work in the Cold Lake region is Victims of Crime Indigenous outreach programming. Cold Lake Victim Services has collaborations between the Cold Lake First Nations and Elizabeth Métis Settlement that are long standing, and are built on strong partnerships. We pride ourselves on our outreach programming in these two communities. We are considered a trusted and accepted "community resource", by leaders in these Indigenous communities. Building on this trust, we, at Cold Lake Victim Services are dedicated to moving this program forward through our tried and tested team approach.

In 2018, our accomplishments include the National Victims of Crime Awareness week in May – June, the third annual RCMP vs Fire-Rescue Charity Hockey Game. Also, our ongoing involvement with community initiatives that include: Cold Lake Bully Free, Child Find ID kits at the Parent Link centre at FCSS Cold Lake and District, Bike Rodeos for the City of Cold Lake, Cold Lake First Nations and the Elizabeth Métis Settlement, various community presentations and Pack the Patrol Car in December. 2018 also marked our final season hosting Operation Red Nose, Cold Lake Victim Services would like to thank all of our partners, volunteers, sponsors and clients for their support over the past eight seasons. We know that our program, run by the community, for the community, has made a significant and lasting impact in helping to reduce impaired drivers and creates greater awareness about obtaining a safe ride home during the Christmas season.

### Municipal Enforcement Annual Report 2018

For the year of 2018 Cold Lake Municipal Enforcement went through significant changes stemming from staffing levels which fluctuated, to bylaw focused education and enforcement, the discontinuation of the Automated Traffic Enforcement program, a revised focus on area specific divisions throughout the city and additional focus in community engagement. Throughout the year of 2018 the department filled all vacancies with five fully trained Community Peace Officer Level Ones, one Senior Community Peace Officer and one term Bylaw Officer, but was not active in 2018. The department encountered some struggles in respect to staffing during 2018. Vacancies included required training, long-term illness and injury and a resignation. Although the department faced these challenges, the dedication to public safety for the residents of Cold Lake continued to be a priority for Cold Lake Municipal Enforcement.

The fully staffed department works a rotating schedule operating during 0600 to 0000 hours, Monday to Thursday, 0600 to 0200 hours, Friday to Saturday and 0800 to 0000 hours on Sunday, but was managed accordingly to maintain coverage during vacancies. The officers' conduct various duties and tasks throughout shifts, such as providing education and enforcement to members of the public in regards to Municipal Bylaws and Provincial Acts, in addition to maintaining and cataloguing lost and found bicycles within the city. Education continues to be provided through an informative process, or addressed on a complaint received basis and delivered in a manner to work with all parties involved in an incident, to ultimately gain voluntary compliance.





The officers with Cold Lake Municipal Enforcement take on several tasks throughout their shifts to ensure public safety, while continually providing prompt, professional customer service to the community. On a regular basis, officers respond to complaints from the public, in respect to animal care and control concerns, traffic control and enforcement tasks, partake in community engaged initiatives, special duties while assisting outside agencies and continually conduct proactive patrols and enforcement throughout the community.

Cold Lake Municipal Enforcement has an outstanding relationship with the Cold Lake RCMP, Cold Lake Fire - Rescue, Cold Lake Ambulance Society, Cold Lake Victim Services, Alberta Fish and Wildlife Officers in the region, Municipal District of Bonnyville Public Safety Department, Commercial Vehicle Enforcement officers in the region and the Cold Lake CFB 4 Wing Military Police. Cold Lake Municipal Enforcement continues to maintain good standing relationships with other organizations such as Alberta Municipal Enforcement Association and Alberta Association of Community Peace Officers.

Cold Lake Municipal Enforcement continually assesses the needs of the community in terms of providing education to ongoing concerns in the City and listening to the concerns of residents. Officers are very passionate, engaged and approachable within the community. Cold Lake Municipal Enforcement is always looking for new methods to contribute and give back to the community, which is evidenced by ongoing involvement with community initiatives and public relations events. Cold Lake Municipal Enforcement continues to work closely with fellow emergency services, community partners, non-profit organizations and local business partner's to host season specific presentations and charity events throughout the year. With these events, the department continues to focus on providing education to participants which promotes public safety and awareness throughout the community.





These events include bicycle rodeos, initiatives with the Cold Lake and District FCSS with Peace Officer meet and greets and neighborhood block party events. Moreover, Cold Lake Municipal Enforcement initiates pedestrian safety presentations with local students and parents while participating in National Child Day and regular school visits. In addition, Cold Lake Municipal Enforcement works with local radios stations and city media sources to disseminate announcements following the Traffic Safety Calendar and season based public safety and bylaw topics.

Events often covered consist of the annual Pumpkin Patrol which provides Halloween safety tips, Pack a Patrol Car which is a Christmas food drive with donations gathered going to the local food bank. Fill a Boat is a summer month based food drive, with donations gathered going to the local food bank. "A Message From Our Kids" challenge encourages all grade 3 classes in Cold Lake to create the best safety messages for residents, which officers distribute upon making contact with motorists. The annual CPO Skate is another great community based initiative. Officers engage with families, while enjoying a friendly ice skate and collecting hockey related donations for local schools. Lastly the Junior Investigator program which encourages youth to locate officers and collect the officers CPO Collector Card in an effort to collect all cards and receive a prize.

Currently the Cold Lake Municipal Enforcement Department, works under the Protective Services Department, which is operated by Manager and Fire Chief, Jeff Fallow. Cold Lake Municipal Enforcement is operates out of the Fire-Rescue Headquarters in Cold Lake south.

City of Cold Lake Automated Traffic Enforcement Program

The City of Cold Lake and Protectives department, along with the Cold Lake RCMP implemented the Automated Traffic Enforcement Program with the assistance of Global Traffic Group Ltd. The very new program commenced on August 25, 2016. The program was introduced as tool to assist, address and accommodate the community's needs pertaining to speed enforcement, red light and stop sign violations and school zone safety. The program was designed to assist the frontline enforcement agencies by utilizing ATE, as method of strengthening public safety and gaining voluntary compliance through enforcement.

Currently, the program has one ATE operator and one mobile ATE vehicle, which is used for enforcement operations. Various hazardous areas throughout the community have been identified as locations of concern and are regularly monitored by the ATE operator. The program is a third party operation, which looks after all certifications, equipment, staffing and other operational necessities. The Global Traffic Group did report to the Protective Services department and the Cold Lake RCMP. As of October 2018, the program had made 2,015 owner/driver contacts, intersection contacts consisted of 387, speed contacts made including contacts in school/playground zones consisted of 1,628.



### Information and Referrals Services

FCSS assists their community through preventive programming and services, including the delivery of Information and Referral Services. In the past few years, there has been a noteworthy increase in the numbers requesting assistance in determining or finding the beneficial supports in the community. As well, many individuals require assistance with the understanding, processing and the use of that information. This may entail actively assisting our clients with their applications for financial assistance, low cost housing and or family supports. It is our determination to help people help themselves. FCSS believes this is the best model that complements its mandate.

### **Counselling Services**


In 2017, Cold Lake and District FCSS offered free counselling services to those without access to a benefit plan. These once a week services were due to a pilot program grant from Imperial. In 2018, again from the generosity of Imperial, the counselling service remained and FCSS was very fortunate to continue with the services of an on-site Registered Provisional Psychologist specializing in anxiety and depression, with expertise in stress management, bullying, anger management and parenting strategies. Supporting Wellness Psychological and Family Services provided support to the Registered Provisional Psychologist.

FCSS is also pleased to announce that the generous funding from Imperial will continue into 2019 and the counselling services will now include one psychologist and two social workers. Counselling will again be to those without access to a benefit plan and will focus on short-term strategies to provide people with coping skills to better handle crisis should it occur.



### Family Resource Library

FCSS continues to market its resource library to the Parent Link Centre, families and the community. Resource libraries help families to acquire the valuable information they would like for their own growth and development and information to improve their quality of life. For the continued success of many programs, it is imperative to keep the information current, which is updated from the contributions and involvement of our many community partners including the counselling team, Living through Grief facilitators and parents.

### Neighbourhood Block Party / Community Rentals

Neighbourhood Block Parties are intended for families and neighbours to build inclusivity and a welcoming community. Families can benefit by providing support to one another and building a safer community. When utilizing the Neighbourhood Block Party Program, a family or organization, on behalf of their neighbourhood, can apply for funding of up to \$100 per year to host an event. Not-for-profit organizations hosting free public events are also eligible to apply for the reimbursement.

FCSS is also grateful to our volunteers who refreshed, repainted and rebuilt some of our community-loved rentals again in 2018. To kick off the Block Party program in 2018, FCSS hosted the first party. This led to word-of-mouth communication, bringing total block party numbers to over 600. FCSS was also proud to support local events through our rental program that attracted almost 6,000 community members.

### VOLUNTEER SERVICES

They also help us with the **Snow Angels Program**, the **Community Volunteer Income Tax Program** and **Emergency Social Services**. Our volunteers play an essential role in the short and long-term success of our organization. They are the embodiment of FCSS: to have an engaged and empowered community of caring, compassionate and supportive people. Our volunteers also serve a vital role at many of Cold Lake's not-for-profit agencies such as the **Cold Lake Food Bank**.

### **Community Volunteer Appreciation Event**

In 2018, 225 volunteers were invited to the Volunteer Appreciation Event to recognize their volunteerism. FCSS collaborated with the *Lakeland Credit Union, Volunteer Alberta, Imperial* and the *City of Cold Lake*. The annual FCSS Volunteer of the Year was awarded to Theresa Legault, who has been volunteering with the *Cold Lake and District FCSS Advisory Committee* for many years. 
### Canada Revenue Volunteer Income Tax Program (CVITP)

The CVITP helps eligible individuals within a mandated income threshold who are not able to complete their income tax and benefit returns by themselves. Introduced in 1971 by the Canada Revenue Agency, the intent of this program is to ensure that all taxpayers have equal access to the tax system.

At Cold Lake and District FCSS, volunteers completed almost 300 tax returns to eligible individuals in our area. Many of those helped are seniors and disadvantaged community members.

Cold Lake and District FCSS promotes this service directly to community organizations for referrals to the program. The Volunteer Facilitator also provides presentations to local organizations including the *Dr. Margaret Savage Crisis Centre*, the *Lakeland Centre for FASD* and all local seniors' facilities. This service highlights the importance for families and individuals to file income tax returns for benefits from subsequent federal and provincial programs, namely the GST rebate, seniors' financial assistance and child and family benefits.

As noted in the graph, 2018 was our most successful year since the inception of the program. We anticipate continued growth for the Community Volunteer Income Tax Program. Once again, our volunteers are extremely significant to the success of the program.

More than 60 recruited volunteers collected 272 turkeys and 1,223 kg of non-perishable items. Cash and gift card donations equaled approximately \$2,406. Sobeys, who has been collaborating with all the agencies involved in the Fill-a-Bus Campaign since its commencement, provided the venue. Their staff and management also provided a number of donations. This initiative requires numerous community collaborations from the collection and packing of the turkeys, hams and other food stuff to the storage and the delivery of the hampers.

#### **Preventive Programming**

Supporting our belief that "investments made in developing and supporting people pay dividends in all areas of community life," we offer programming that is designed to give our community members foreknowledge about important issues in order to keep them mentally and socially strong and to build resistance to crisis.

#### **Child and Youth**

Child and youth programming includes support with the journey into independence, healthy lifestyle choices, cooperation and peer engagement. Life skills, and social competency and development remain the focus of our program creation.

#### Adult

Programs at FCSS, including parenting workshops, are developed to improve the quality of life of individuals and families and build resilience to cope with crisis. "Living through Grief" is designed to assist with the emotions and stresses that happen after a loss.

#### Family

Providing events for families to attend which promote family communication and connections is an important part of our services. In 2018, we welcomed more than 800 to our annual National Family Week Kick-off Event.

#### Community

FCSS continues to collaborate with its community partners to offer a wide range of programs and services that connect community members and reduce gaps in social services.

#### 2018 PROGRAMMING AT A GLANCE

#### **Family Programming**

Cold Lake and District FCSS and the Parent Link Centre have been involved in a few projects this year to try to help families understand the importance of the protection and sustainability of our earth. The hope is that those who experience nature education will develop positive attitudes about themselves, natural life, and the earth.

The *FinS* program introduces families to the raising of fry at the Parent Link through the winter months to their summer release in a community lake. The Parent Link Outreach raised painted lady caterpillars and in the summer, parents and children released the butterflies.

Children and youth of the community learned life skills from collaborations with FCSS and the **Cold Lake Community Garden.** Community gardens can serve as an outdoor classroom where all family members can learn valuable skills, like those involving practical math, communication, responsibility and cooperation. They also provide the opportunity to learn about the importance of community, stewardship and environmental responsibility. Community gardens offer unique opportunities to establish relationships within and across physical and social barriers. At every opportunity, new programs with FCSS and the PLC are developed with the intent to help individuals adopt healthy lifestyles.



On September 28, 2018, FCSS hosted their annual *Kick-off to National Family Week Event*. National Family Week was proclaimed an official week by the Canadian Government in 1985, and Cold Lake and District FCSS has been participating in the event for nearly a decade. Traditionally 500 patrons attend our event but this year our numbers grew to approximately 820 patrons, which is the largest number since the inception of the event.

The aim of this event is to encourage family connections, to strengthen the family unit by spending time together, and to promote the programs and services offered by the PLC, FCSS and our community

FCSS strives to create an atmosphere of a neighbourhood block party, where families and communities can unite and build strong bonds.

FCSS also delivers the *Family Adventure Program* and *Family Fun Nights*. The Family Fun Nights are one of our most popular events,

which unite families of all ages. Together these two programs bring in more than 1,000 community members where staff can also outline our additional programs and services. These are great opportunities to promote inclusiveness, community connections and engagement.



## **Children and Youth**

FCSS Children and Youth programs are designed to assist children learn new skills, form greater social skills and develop social responsibility within the community.

In early 2018, the Child and Youth department began another year of new partnerships beginning with personnel from *4 Wing Cold Lake*. It was especially exciting to have engineers from 4 Wing assist with *Silly Science Saturday, Journey through the Clouds*. It was their experiences as jet pilots and flight engineers that heightened the classroom experience for the young 6–8 year olds in the Silly Science Saturday program.

Approximately six times a year, children spend the day learning how to be safe and feel empowered when staying *Home Alone*. They make a safe snack, learn about cyber safety and how to deal with siblings and friends when home alone. In the afternoon *Cold Lake Fire Rescue* teaches fire safety.

FCSS *Garden Gnomes* didn't let April's cold weather stop them from getting the garden season started. They planted tomato seeds and later in the year, prepared the garden for the seedlings and harvested the vegetables.

July was an exciting month at Cold Lake and District FCSS. The Loft was completed and welcomed by the general public for the grand opening, with representation by the Cold Lake Mayor and from Council and the FCSS Advisory Committee. Also in attendance was our FCSSAA Northeast Regional Representative, Amelia Harmse, Glenn Barnes, the City of Cold Lake General Manager of Community Services and Kim Schmidtz, the FCSS Manager. The Loft will be used for programming, and includes a movie theatre, kitchen, and recreational space. July included the following workshops.

August was also a full month for child and youth programming; 17 programs were offered with 175 children and youth in attendance. Five new programs for the 13-17 year old age group were added to the curriculum.

In *Lunch Box Heroes,* participants learned kitchen, food and knife safety and then put their new recipes to the taste test. With their learned skills and recipes they packed their own lunch, teaching them responsibility and ownership.

Nine youth received their training with **YESS** (Youth Epic Summer Squad) and put their skills into action by volunteering at **The Cold Lake Food Bank.** They were trained in customer service, basic first aid, young workers' rights, and dealing with difficult people. YESS allows youth to make a

positive impact on their community through the value of volunteering and the knowledge that their contributions make a difference.

An eight-week *Creating and Publishing* course came to an end in the fall. All youth that registered composed either a zine or chat book, comic or play write. This program gave youth a safe place to connect with their peers, while promoting confidence and self-expression.



Our *Silly Science* workshops, funded by *OSUM* in 2018, are designed for children to be comfortable with learning science, while building unique social skills. LEGO<sup>™</sup> programming provides youth with the challenges of leading a group, sharing and taking turns. *LEGO<sup>™</sup> Explorers* is a program developed for children with Autism Spectrum Disorder. All facilitators, including youth mentors, are formally trained to deliver this program.





The *Cold Lake Youth Council* also contribute to the community. In addition to their monthly meetings, in 2018 they volunteered at the *Cold Lake Anglican Church* for the community supper program, the *Cold Lake Lodge* and the *Cold Lake Food Bank*, amongst others. In total the Youth Council volunteered 470 hours in 2018.



## **Child and Youth Components**

## Life Skills and Social Competency for children 6-11

This element includes programming that introduces healthy living concepts such as financial understanding, safe food preparation and the sustainability of our planet through such programs as Garden Gnomes.


## Social Skills and Development for children 6-11

FCSS provides four LEGO<sup>™</sup> programs that all promote positive peer relationships and belongingness. The intention of programming includes the development of interpersonal skills and a commitment to learning.

**Character Education for children of all ages** includes the advocacy and teachings of moral intelligence in alignment with local schools.

## Youth Advocacy and Empowerment for youth 12-18

The Cold Lake Youth Council advocates for change in the community. FCSS promotes positive values such as caring and integrity through youth programming. Youth acquire empowerment by helping out in the community and being of service to others.

## **Community and Parenting Education**


In 2018, our FCSS and Parent Link Outreach staff spent numerous hours at the Cold Lake Food **Bank** delivering information about our programs and services. For instance, the Volunteer Services Facilitator, handed out brochures and information on the Community Volunteer Income Tax Program while the Parent Link Outreach Facilitator provided families with materials on outreach programs and services delivered through the Parent Link Centre.



The Family Services Coordinator delivers character education to school children, and at public events through the assistance of our mascot Ted E. Bear. Moral or character education teaches children moral intelligence skills that instil the virtues of empathy, respect, self-control, conscience, kindness, and perseverance. It is important for children to grow and learn in an atmosphere that is safe and caring, and promotes basic human values. Character education is skills based; participants learn how to exude the personal attributes of empathy at school, in the community and at home. FCSS strives to incorporate the same monthly traits through our Parent Link programming.

Our Community Response to Elder Abuse Team representative from FCSS addressed numerous groups this year on the delicate nature of Elder Abuse and how our community can recognize, acknowledge and assist when there is a concern of elder abuse.

While the Family Services Coordinator and the Parent Link Facilitators deliver parenting programs during regular hours at FCSS, The Parent Link Outreach Facilitator also delivers parenting and specialized courses at schools and other centres in our area to parents and professional peers who are unable to attend our regularly scheduled classes at FCSS.



## **Parenting Education**

## **Collaborations and Community**

In partnership with *Alberta Emergency Management Agency*, FCSS facilitated *Registration and Inquiry* and *Persons with Functional Needs*. Participants have the opportunity to volunteer for our ESS Volunteer Program, should a disaster occur in the area requiring assistance from FCSS.

From the *Telus World of Science* in Edmonton, Cold Lake and District FCSS brought the Mobile Planetarium to three different groups for three separate workshops. First, the PLC Outreach hosted an exploratory learning event, adapted for families and children under six. Then the Child and Youth incorporated the planetarium into their Silly Science Saturday for the Stars, Constellations and Galaxies. For the final day of the visit, all families and the community were invited to the Cold lake Energy Centre for an afternoon of Journey through the Stars in the Family Adventure Program. In total almost 200 children and family members took part.

The **TELUS World of Science Mobile Planetarium** also took a trip around the Lakeland Parent Link Network mid-September. This early introduction to the space sciences offered families an opportunity to learn about stars, and talk about light and dark. They also had a chance to visit the mobile library by looking at books to feed their curiosity, build space "crafts" and use gross motor skills for the activities outside of the planetarium. This program also reduces barriers to science programs that are often only offered in larger cities. Throughout the Lakeland, there were 343 Parent Link participants, with 82 participants from Cold Lake.



This year's **National Child Day** Theme was "It's Our Right to Identity". The **Early Childhood Development Coalition** felt this was a great opportunity to invite local citizens to showcase different cultures and traditions. Included were a local clogging group, an interactive garba dance as well as the KCEC Pow-wow dancers. Interactive booths were set up to encourage a learning atmosphere for children. They had opportunities to learn about the environment through **LICA**, explore their identity and culture through the Pop Up **Library** Branch, and create a physical record though **Victim Services** and **Child Find.** In total 26 professionals were on site representing 13 agencies from the Cold Lake and area community.

A team of community professionals and members invested in early childhood development coordinate the National Child's Day event. The *Early Childhood Development Coalition* formed in 2012 in response to the EC Mapping project criteria to support early childhood development in our community. The Coalition's purpose is to promote positive early childhood development. To that end, they work together through a coordinated, collaborative approach while building community capacity to support optimal development of all children in our community.



The City of Cold Lake was one of 16 pilot communities from across Alberta to receive grant funding from the *Alberta Cancer Prevention Legacy Fund*, Alberta Health Services, to implement the Alberta Healthy Communities Approach (AHCA). The AHCA works with communities to discover their strengths through a community-driven process to create healthy places and social spaces for all. The *Cold Lake Healthy Choices Count Coalition* was formed in the fall of 2015. A core team of six community members and stakeholders came together to work towards creating healthy choices Count Coalition is to support the community of Cold Lake to be a healthier place to live, work, play and age. The Coalition erected shade tents in various locations. As part of the healthy eating strategies, a goal was developed to increase affordable healthy food options to community members through organizations. Five garden towers were erected at various facilities, including FCSS with one in the Loft and one in the Parent Link Centre.

Walk in Another's Shoes was the theme for the **2018 Festival of Words**, to build an understanding of empathy and compassion. This event has been taking place in Cold Lake for more than a decade. **The Cold Lake Community Learning Centre** facilitated the collaboration of this multi-agency event, which attracted 220 community members.

This year the *Early Childhood Coalition* had 21 members on site representing a variety of community agencies for the annual *Ages and Stages Spring Screening*. 39 children were screened with both the ASQ 3 and the Social Emotional questionnaires. 40 parents were in attendance and reported that they gained an increase awareness of what to expect as their child grows and became more aware of community resources.



Our Annual *Pink Day,* a collaboration with the *Cold Lake Bully Free Committee, the RCMP,* and *FCSS* results in a multitude of residents meeting for the yearly walk along Cold Lake's main avenue. With information and speeches on anti-bullying, the message generated is that Cold Lake will not tolerate bullying. Students, teachers, the City of Cold Lake Mayor, staff of FCSS and the general public ended the walk at the *Cold Lake Middle School* for a luncheon courtesy of the *Lakeland Centre for FASD*.



#### Adult and Senior Programming

Cold Lake and District FCSS has been partnering with a grief consultant for over a decade to deliver the *Living through Grief* series, which assists those to effectively deal with their feelings of grief and loss.

*Wills, Personal Directives and Power of Attorney* is a program delivered through the long-time partnership of a local lawyer. In 2018, there was a marked increase in attendance. Also noted was a much younger audience than in past years. This workshop helps people prepare for the future by providing information to deal with life's difficulties.



Adult programming provides individuals

with the skills to build resiliency and strength, become more positive and improve the quality of their lives. For instance, in *Emotions 101*, participants explored different way to interpret emotions and therefore to communicate more effectively.

FCSS also collaborated with the *Alberta Family Wellness Initiative* to deliver the *Building Better Brains* conference. Multiple Cold Lake and area organizations were in attendance.

The Alberta Emergency Management Agency (AEMA) has been very proactive in preparing FCSS staff and community volunteers for future emergencies. AEMA also facilitated an emergency management course for the public. The response was encouraging and Cold Lake has seen a rise in volunteerism for organizations such as the Red Cross and for their Emergency Social Services.

FCSS also collaborated with the *John Howard Society* to assist people to complete the Rural Homelessness Estimation Survey, which has been endorsed by provincial leaders including the Alberta Association of FCSS.

Adult programming includes events such as the monthly *Feast to Friendship* luncheon for isolated seniors. This program emerged from the intention to improve the quality of life by reducing isolation for shut in seniors. FCSS partnered with *Alberta Health Services, Home Care* to host monthly luncheons from August to December for isolated seniors. There have been multiple successes within the group; isolation in many of the participants has decreased and friendships have formed. This initiative will continue into 2019, in partnership with the *Cold Lake Middle School.* 



The *Every Age Counts Coalition* distributed elder abuse surveys in the community. Monthly articles written by FCSS on Elder Abuse were printed in the Cold Lake Sun. The purpose of these events is to bring more awareness and the impact of elder abuse.



**CREAT** or **Community Response to Elder Abuse Team** was created with the support of a grant from the Ministry of Seniors and Housing with the Government of Alberta. The objectives are twofold. First, the team supports the development, enhancement and implementation of a sustainable coordinated community response model to

prevent and address elder abuse throughout five communities in the northeast region of Alberta, including Cold Lake. Secondly, the team supports enhanced capacity within those areas to prevent and respond to elder abuse, through improved coordination among service providers.

The **Snow Angels** initiative is especially helpful to seniors who may want the independence of remaining at home, albeit with some assistance. Some seniors will also benefit from the CVITP and our volunteer services in general.

All community members, including seniors are welcome and encouraged to drop into FCSS for assistance with federal and provincial forms. FCSS promotes this service directly to the Cold Lake Seniors' Society and all seniors' housing facilities as well as to the community in general.



FCSS allots grants for those that enhance the social well-being of individuals and families through prevention or intervention strategies provided at the earliest opportunity. Priority is given to those that highlight partnerships and have the potential for the greatest community impact.

## 2018 FCSS GRANT DISBURSEMENT






## FAMILY ENRICHMENT PROGRAM

There are many ways to take advantage of these opportunities, which include workshops, support groups, public education, and individual sessions with our Family Services Coordinator.


We are able to provide a range of information on topics including child development, parenting, crisis management, life transitions, and relationships skills.

When in discussions with clients, the Family Services Coordinator will often make referrals to other organizations, such as Alberta Health Services. Client concerns range from anger issues to parenting difficulties. Cold Lake and District FCSS will offer a variety of resources to assist the client, whether it is recommended reading materials, one of our many parenting workshops or a referral to another organization.




## **Referrals to Family Services 2018**





## **Referrals from Family Services 2018**






## COLD LAKE PARENT LINK CENTRE

## Parent Link Centre Programming

In January and February the Cold Lake Parent Link Centre concluded their *Infant Massage*, put on two *Family Fun Nights* and offered eight sessions of *Baby Connections*. In addition, they continued with their *Triple P*, *Handle with Care* and *First Sounds First Words* parenting education. On a daily basis, the Parent Link Centre Facilitators keep the centre clean and organized and conduct daily activities. This may include an arts and crafts project, or another early childhood development program. The *St. Valentine's Day Party* at the Cold Lake Energy Centre included activities such as valentine cookie decorating, meant to build fine motor skills.

Parent Link Centre staff are trained to deliver *Triple P Parenting Programs*. In May, *Hassle Free Shopping* was the third parenting program to be offered in 2018. This discussion group offers suggestions to parents on how to avoid stressful shopping experiences and ways for children to behave responsibly.



For the 4th year, music teacher Ruth Snyder was back with the *Music is Fun* program with our Parent Link families. The Music is Fun program offers an opportunity for structured learning and increases school readiness by teaching children how to wait their turn, follow instructions, develop listening skills, and increase positive social skills. Exposure to music from early childhood onwards helps children to speak more clearly,



develop a larger vocabulary, and strengthen social and emotional skills. This 10-week program includes weekly themed activities with music, songs, dancing and crafts.

The *FinS* program helps children understand our environment. The fish were released by the children with the assistance of the Park Conservation Officer at Little Bear Lake. Later at the Fish Hatchery, the children had the opportunity to catch the fingerlings with a net and feed the older fish. At the end of the tour the children had a close up view of a variety of fish placed in basins. They were able to catch and hold the fish. Overall, FinS aims to instill a sense of environmental stewardship in all participants.

The Parent Link Centre hosted an *End-of-Summer* event filled with activities inside and outside the Parent Link Centre. The end of the summer season is a time to wish great success to the many young children who will be attending kindergarten and pre-school in the fall. This event provides children with a sense of belonging and fosters bonding within and among families.

In December, in partnership with *Feast to Friendship*, children and guardians from the Parent Link Centre joined the seniors for singing, lunch and Christmas themed crafts. It is the vision of FCSS to ensure that seniors are connected to the community and the Feast to Friendship initiative proved to be that vehicle to reduce isolation.

#### Parent Link Centre Special Events





## LPLN REGIONAL ADMINISTRATION AND PLC OUTREACH PROGRAM

Cold Lake has taken the opportunity to hold the Lakeland Parent Link Network (LPLN) contract with Child and Family Services for the fifth year. The Parent Link Network includes Bonnyville, Lac La Biche, St. Paul and Cold Lake.

"At each of these sites, parents can expect high-quality, accessible, community-based programs that comply with province-wide standards of excellence and respond to the changing needs of parents and families. This is done to promote family wellness, positive parent-child relationships, improve parenting knowledge and skills, foster optimal child development and ensure that children get a healthy start in life."

The role of the LPLN Administrator is to keep a record of the region's finances, as well as submitting mid-year and year-end reports to the province, entailing unique program users, participant surveys, and Triple P parenting outputs. Other notable projects include the monthly regional newsletter and calendar of events, planning regional activities for families, and finding unique training opportunities for the PLC programmers. The Administrator also acts as a liaison between the programmers and the management team.

The Parent Link Outreach Programmer offers programs in efforts to promote early childhood development within the Cold Lake area.

The Parent Link Outreach Facilitator introduced her new acronym, **PLOW** (Parent Link on Wheels) for the delivery of monthly outreach programming. In January, PLOW met with families for early childhood development opportunities in the *Cherry Grove Hall* and in the *Seniors' Centre* in Cold Lake. Additionally, the Facilitator began her monthly visits to the *Cold Lake Food Bank* with information on family programming and activities. Parent education included *Kids Have Stress Too* and *Emotion Coaching* at *North Star Elementary School*.

The PLC Outreach partnered with the Early Childhood Development Coordinator at *Alberta Health Services*, and the Parent Link Centre. The six-week *Sensory Exploration* program provided

the opportunity for children to navigate their environment by engaging in a variety of sensory experiences including an obstacle course and messy play. It also provided opportunities for early childhood development in the six developmental domains of fine motor, gross motor, communication, personal-social, problem solving and social emotional skills. This program was developed as a result of Early Development Instrument Data that was released early 2018 and in



response to families completing the Ages and Stages Questionnaires.



After the great success FCSS had on Valentine's Day partnering older adults with children from the Parent Link Outreach Program, we were encouraged to adopt more programming around family and adult relationships and support. The *Ice Cream Social* at the *Cold Lake Hospital* demonstrates how the community welcomes and values young children. The children provided meaningful actions by serving the ice cream to the seniors. Families learn empowerment by performing simple caring actions to others. This is a great event to also teach all people about community connectedness and social engagement.



**Douglas Country Creative Play** offers an outside adventure for young children to play in the koi pond, mine for gold and visit the fairy village. When children play outdoors, it facilitates cognitive, physical, social, and emotional well-being. Children learn many things and develop self-confidence and awareness of their surroundings. They explore and learn valuable life lessons.



Hosted at the Provincial Park in partnership with **Boreal Forest Guides**, families had an opportunity to learn about the plants in the park and how they can be used or avoided. Families are also encouraged to hike and participate with their children throughout the duration of the program which includes a scavenger hunt, plant identification, tree dating, fairy house building, javelin target practice, and a craft. Families are encouraged to engage their children in discussions around boundaries by staying on the trail and integrity by following instructions, and self-regulation. This program benefits physical health, enables exploration, and is a rewarding experience for young children. The children also have an opportunity for free play at our Provincial Park playground. It allows for parents to connect with one another and it fosters a sense of appreciating natural play while engaging the senses.



## OUTCOME MEASURES

Every local FCSS program and service offered to the community are based on the needs of that community. Outcome Measures help staff make decisions on the implementation of current programs and the development of new programs and services. Outcome measures provides FCSS with data on how their programs make a difference for individuals, families and communities. It shows the outcome of FCSS contributions of time and resources. It also helps local FCSS programs and stakeholders understand what programs and activities are most successful and where changes are needed, to make them work better.

For instance, there were 225 in attendance at the *Volunteer Appreciation* event in 2018. FCSS received completed surveys from 137 people. They were asked three questions on the impact of their volunteerism. Almost 100% agreed that they felt recognized by and important in the community while 90% felt that they had made the world a better place.

Guests of the Volunteer Appreciation Event were also asked to identify a unique experience of volunteerism that had an impact on them. We received fifty eight positive responses. These are a few of the replies.

- Cold Lake Food Bank and Community Supper make me feel the most valued and that I am making an impact.
- \* Getting to work with a fun group like Best Buddies really highlights the importance of friendship, inclusion and having a sense of community and belonging.
- Coaching has had an incredible impact on me as I continue to watch youth learn, grow and achieve their goals.

The Cold Lake Youth Council gathers monthly to discuss issues of importance to their peer group. The Cold Lake Youth Council played an important role in the development of the City of Cold Lake's public transportation service by sharing a survey that was undertaken by Cold Lake youth. The Youth Council makes an impact in the Cold Lake community through their volunteerism.

At the end of the year, in the post event survey of the *Cold Lake Youth Council*, the following questions were asked.

- \* I am more involved in civic processes and what happens in my community.
- \* I get more opportunities to help make my neighbourhood and community a better place.
- \* Cold Lake Youth Council has helped me feel that I can make a difference.
- \* I feel that what I have to offer is more appreciated by my neighbourhood/community.

In all responses there was 100 percent positive feedback from all members of the Cold Lake Youth Council.



The Cold Lake Better Brains Conference was a collaboration with *Portage College*, FCSS and the *Alberta Family Wellness Initiative*, who provide education on the science behind early childhood brain development.

"As a community, when we identify how and when to support children and families in the course of development, we can change how the story unfolds so that all of us, regardless of background and life circumstances, have the chance to lead happier, healthier lives, build stronger communities, and reduce risk for mental health problems, including addiction."

The conference, led by Dr. Nicole Sherren, Scientific Director from the Palix Foundation was intended to provide attendees with a deeper understanding of the core story of brain development and its link to addiction and mental health and the impact of toxic stress on health and wellness. A measurement of the conference is as follows.

- \* As a result of the Better Brains Conference I am more aware of how children change as they learn and grow. 88% agreed with this statement.
- \* As a result of the Better Brains Conference my organization has more of the necessary skills to help address this community social issue. There was 79% agreement with this statement.
- \* 85% of the participants agreed that as a result of the Better Brains Conference they developed better working relationships with other community agencies.

FCSS considers these outcome measures as very good results. Combined with the comments from course members, in the future FCSS will include a component that would provide more tools in the course outline, allowing participants to acquire the skills needed to address the issue.

**Community Registration Day** is a very big annual event in Cold Lake. Once a year, organizations unite under one roof to showcase their programs and services. FCSS was able to elicit responses from 59 individual family members. Almost 100% of respondents agreed that as a result of community registration day, they were more aware of what was happening in their community.

The *Feast to Friendship* luncheon for isolated seniors was intended to improve their quality of life by reducing the isolation. Outcomes measures proves that this was highly successful as 100% of participants agreed with the following statements.

- \* As a result of the Feast to Friendship Luncheons, I feel more connected to a group of people who share my beliefs and values.
- \* As a result of the Feast to Friendship Luncheons, I am more connected with others in my community.
- \* As a result of the Feast to Friendship Luncheons, I know more about how to access the community resources I need.

# 2018 Annual Recreation Report



# **City of Cold Lake**



Cold Lake Marina	Due to the late spring melt/thaw, installation of the marina docks was delayed, but through the tenacious and dedicated efforts of operational staff, the Marina was open to the boating public midway through the May long weekend. Dock chains were monitored daily and adjusted for fluctuations in water levels. A couple of significant summer storms along with fluctuating water levels resulted in a number of dock units being removed at seasons end for more repairs. In preparation for the annual Snow Fever festivities, Parks operations made two skating surfaces on the lake surface at the Marina. Sagar Properties oversaw the day to day operations of the Marina and also were in charge of fuel, maintenance and overnight security. Sagar Properties crew also assisted with building the marina shinny rinks.
Marina Building	2018 also saw the leasing of the former Waters Edge restaurant to a local proprietor who opened Johnny Waffles in the late summer. Operational staff were tasked with the removal of selected large appliances to storage including a double decker pizza oven.
Marina Slip Allocations       All 236 slips in the marina were allocated in 2018.	
Marina Wait List	There are 189 individuals on the Marina Waitlist. In 2018, 19 slips became available and were filled by people off the waitlist.

## Energy Centre

The Energy Centre increased their programming for 2018 and brought the community through the doors. There were many events held in 2018 whether it was the sold-out Nelly concert in the Reid Fieldhouse, or events such as Yuk Yuks and Dueling Pianos, attendance numbers grew from the previous year. The Energy Centre was busy all year hosting galas, tradeshows, and parties. The Wellness Centre increased their equipment and continued to develop more programs to offer the community.

2018 saw the completion of the third expansion phase of the Energy Centre, which consists of a new (second) ice surface along with a "high performance" climbing wall, a new lounge space overlooking both ice surfaces, additional meeting rooms, office spaces, and additional storage space. The second ice surface necessitated the installation of a third compressor to the ice plant system. Construction was completed in late July with the ice skating surface made for the September opening. A few minor changes were completed after opening including safety netting along the north wall and re-location of the score clock to the northeast corner for better visibility.

There are still a few more details to be completed in 2019 including installation of the skating harness, installation of privacy walls in the new dressing room for Cold Lake Figure Skating Club, and the purchase of furnishings for the new lounge and the newly extended main corridor/north entrance.

2018 also saw the inaugural season for the Cold Lake Wings Jr. A Hockey club as a member of the Western Provinces (WPHL) Division of the United States Hockey League (USHL). Accommodations were made to assign the team with a dedicated dressing room. This room was renovated in December to provide individual player stalls and a coach's wall, along with stick and coat racks at the entrance into the room.

Operations took ownership of a new Zamboni 526 ice resurfacer unit. The new unit was equipped with some new operational features including a new snow auger wash system, and a new electronic diagnostic system which will allow for remote monitoring of unit operations with the intent to develop more efficient operational procedures as well as more timely maintenance and troubleshooting capabilities.

Local entrepreneurs leased the lower concession space in the Imperial Oil Place Arena to open a new Booster Juice franchise to offer a healthy choice alternatives to the traditional burger and fries found in most arena facilities. Construction/renovations began in October and completed in time for the scheduled "soft" opening in mid-December

January 13 <sup>th</sup> was our first Mascot Skate Day – Eight organizations with a total of 100 community members attended.
The 4 <sup>th</sup> annual Snow Fever (previously referred to as Winter Fest) was held at the Cold Lake Marina on February 18 <sup>th</sup> . There was a hot dog/marshmallow roast over an open fire, Ice on Whyte came back again to dazzle the crowd with their ice sculptures, ice slide, and ice carving lessons. A few other activities that took place included a pond hockey tournament, sleigh rides and a sugar shack.
March 29 <sup>th</sup> marked our first Easter Eggstravaganza and it was a huge success! There were games, crafts, cookie decorating, bouncy castles and sparkles tattoos. We had approximately 1,000 people out on Thursday evening for the event – a great way to start the long weekend!
We kicked off our concert calendar this year with Nelly on April 20 <sup>th</sup> . Not only was it a sold out show but it was the most profitable concert of 2018!
The Energy Centre staff joined in on celebrating Senior's Week on June 8 <sup>th</sup> , where we saw local seniors come out and enjoy a morning filled with fitness classes, bingo, flower arranging, pickle ball, and a BBQ lunch followed the jam packed morning.
Canada 150 really set the bar for our annual celebration and this year Cold Lake took over the Marina to the Kinosoo Beach. Family activities took place throughout the day and the festivities continued into the evening with 90s band, Prozzak! The celebrations didn't stop there as we capped off the night with an amazing display of fireworks down at the Cold Lake Marina. On July 20 <sup>th</sup> we kicked off the 4 Wing Air Show with our Full Throttle Street Festival, taking over 50 <sup>th</sup> street. We lined the street with bouncy castles, video arcades, family activities, a 144' x 86' beer garden and a huge mobile sound stage. Big Sugar headlined the event and 4 Wing joined us for a CF-18 fly-over.
Aqua Day was held down at Kinosoo Beach on August 5 <sup>th</sup> . This year marked the 5 <sup>th</sup> annual Cardboard Boat Races with 12 teams entered to compete for the winning title. There were also bouncy castles, water inflatables, face painting, foam pit, local Lakeland vendors, a sand station and a free community BBQ. The day was a huge success for the community! Community Registration Day was held at the Energy Centre on August 25 <sup>th</sup> . This event is held in conjunction with 4 Wing, Cold Lake Community Learning, and the City of Cold Lake. Approximately 71 organizations participated in this community event.
On September 16 <sup>th</sup> the Terry Fox Run was held down at the Cold Lake Marina, this year we were plagued with inclement weather, rain, sleet and high winds. This led to lower participation – only 51 participants that helped to raise \$ 3,855 for the Terry Fox Organization.
We hosted John Mellencamp and 1,400 community members enjoyed an unforgettable concert. It was part of the Sad Clowns and Hillbillies Tour. This concert brought in \$11,263.75 in revenue. The City of Cold Lake, 4 Wing, and The Royal Canadian Legion 211 partnered once again for the Remembrance Day ceremonies which were held in the Imperial Oil Place Arena with 2000 attendees. A luncheon was held after the ceremonies in the Reid Field House. The Santa Claus Parade was held on November 30 <sup>th</sup> on Cold Lake Main Street, there were approximately 65 businesses and local organizations that entered floats this year.
On December 15 <sup>th</sup> the Reid Field house was rocking out to the Duelling Pianos. The duelling pianos were performed by Kickstart Entertainment, followed by a local DJ. The event grew in size from the year prior, selling almost 100 more tickets in 2018.

Parks	<ul> <li>Plans were initiated to expand two existing playgrounds on 4Wing Cold Lake – Evergreen Park and Birch Park. This work was completed in July with both park play areas expanded approximately 1200 square feet each to accommodate a handful of new stand-alone play features for continued enjoyment of local residents.</li> <li>Other park/playground improvements included installation of new park signage at selected playgrounds throughout the city, and the completion of a new section of paved walking trail along Palm Creek (Cold Lake South) between 53<sup>rd</sup> and 54<sup>th</sup> Avenues west of 57<sup>th</sup>/58<sup>th</sup> Streets.</li> <li>Parks operations was also tasked with installing Christmas decorations on light poles along Highway 28 through the City to the Marina, and installing and maintaining banners along Highway 28 and on 1<sup>st</sup> Avenue along Kinosoo Beach.</li> <li>Parks operations also attends to the proper operation and maintenance of the splash park on 4Wing Cold Lake. In 2019, there are plans for a new playground installation adjacent to the splash park on 4 Wing Cold Lake as well as consideration to repaint the markings on the splash park pad.</li> </ul>
Cemeteries	Operations continue to provide regular maintenance to both cemetery facilities (Lakeview in the North and Grand Centre Memorial Park in the South) including grass cutting, garbage/litter detail and snow removal (winter), as well as plot marking as required.
Greenspaces	The City continues to participate in the Communities in Bloom Program with enthusiastic parks staff facilitating and participating in the local committee. Some of the events hosting including a plant exchange and pruning course. More events and activities are being scheduled for 2019 as the committee plans move forward in the program. As part of the CiB Program, inspections identified three major areas within City limits that had become infested with Common Tansy, a prohibitive noxious weed. A total area of 551,290 square meters of public lands were addressed. Continued inspection and spraying for the presence of noxious and prohibitive noxious weeds will be the order of business going forward. Parks operations continued with its regular level of services in 2018 including, garbage detail throughout the City, maintaining hanging floral baskets along Main Street and various ornamental displays throughout the City – service level was expanded to provide additional displays at FCSS and Fire Services building. During the winter months, operations have been busy with maintaining snow removal duties along Millennium Trail and its various connector routes as well as bus stops along the trail and major crosswalk along Highway 28. Entrance sails were repaired and re-installed in time for the commencement of the tourist season and inspected to ensure that they would be able to weather the winter season.

Outdoor Rinks	During the winter months, the two outdoor skating rinks were flooded and readied for public use in time for the Christmas break. These facilities are maintained on a weekly or as needed basis (weather and time/resources permitting) throughout the winter season.
Kinosoo Beach	Operational staff were involved in the installation of the newly acquired Zip Line at Kinosoo Beach. Contractors conducted the initial installation which Parks staff observed, while Parks staff were tasked with its removal as seasons end.
	Parks operations were also tasked with daily/regular maintenance of the facility throughout the summer season which included daily "raking" of the beach sand, garbage detail, and splash park start up/shutdown and regular maintenance, and seasonal installation and removal of the swim markers.
	Kinosoo Beach/Park was expanded to facilitate the install of a new playground structure. The new installation has a play area measuring approximately 4500 square feet on the upper tier of the park space created through the removal of a significant portion of an existing stand of trees. The installation is appropriate for children $5 - 12$ years of age and has been a welcome addition to residents of the area and community.
	The lower and west park areas was outfitted with an irrigation system, and the area below the new playground installation was partially sodded. System will be operated and maintained by Parks operations in 2019.
	2019 will see the remaining park area around the new playground installation landscaped and sodded, with a potential removal of the remaining forest and expansion of the irrigation system into this area in the coming years.
