## **Cold Lake Fire-Rescue**

### Fire Calls, Accomplishments and Events

#### Fire Calls – 22 in total

During the month of January there were twenty-two (22) fire calls that Cold Lake Fire-Rescue (CLFR) responded to. CLFR responded to one (1) vehicle fire which was extinguished quickly but a total loss and was deemed a suspicious fire. CLFR responded to one (1) motor vehicle collision (mvc) during the month which was a minor collision where both vehicles were able to be driven away and Command stood down responding apparatus as additional fire response was not required. Of the sixteen (16) alarm calls CLFR attended, all were deemed to be false alarms. Eight alarms were residential fire alarms, seven were commercial/institutional fire alarms and one was a CO alarm. The fire alarms activated included: four from cooking smoke, three due to changing the battery, three from pipes bursting during the cold snap, two with pull stations being pulled by children accidentally, one due to system fault, one from smoke caused by a smoking floor receptacle and one from system maintenance. The lone CO alarm was checked with CLFR equipment with low readings found. The cause of the alarm was determined to be from a chemical sealer. CLFR responded to two (2) contents fires both with minimal damage. The first incident was for some scorched siding on a garage where a neighbor witness somebody lighting a fire with gasoline. This fire was deemed suspicious. The second incident was for some clothes in a dryer catching fire. The cause of the fire inside the dryer drum was attributed to a clogged dryer vent and deemed nonsuspicious. Finally, CLFR responded to two (2) public assistance/other calls. Both were good intent calls and included one for a possible person jumping over a guardrail and falling down an embankment and one for a sighting of a fire flash and smoke behind a stove. In the first incident the person walking on the side of the road was located and indicated she jumped over the guard rail as she thought a motorist was too close to her. In the second incident fire crews checked the stove and found the power cord had been compromised causing the arc and subsequent smoke. The homeowner was advised to have an electrician check the stove before plugging it back in and using it.

During the month CLFR responded seventeen (17) times within City limits and five (5) times in the MD of Bonnyville. Daytime responses [0800-1600] (9) were the highest response times at 40.91% followed by evening response [1600-2400] (8) at 36.36%, with overnight response [0000-0800] (5) being at 22.73%.





## Items of interest


- Municipal Enforcement conducted several patrols following snow routes and seasonal parking locations.
- Municipal Enforcement continued to provide a visible presence at the Cold Lake Ice hockey games. Officers continue to take the opportunity to meet with the public, provide a visible presence and conduct patrols of the Energy Centre during the evening events.
- Municipal Enforcement initiated planning of Alberta Traffic Calendar operations with the partnering agencies. The hope is to plan events following the provincial traffic safety calendar.
- Municipal Enforcement worked with the Alberta SPCA on an animal welfare investigation.
- Municipal Enforcement continues to patrol Cold Lake's outdoor rinks on a nightly basis while assisting with lock up functions.
- Municipal Enforcement intervened in an altercation between two parties at the Energy Centre.
- Municipal Enforcement initiated an investigation after being alerted to the discovery of graffiti at the Energy Centre.
- One officer received their Peace Officer appointment and will continue working in an on the job training capacity.

Municipal Enforcement continues to provide education and enforcement initiatives in all Cold Lake school zones and playground zones which consisted of thirty-nine patrols for the month of January. Municipal Enforcement continues to actively conduct patrols of the downtown core, marina, and alleys within officer divisions, beach recreational areas, outdoor ice rinks and recreational green spaces within the city. The patrols allow Peace Officers to liaise with community partners; and provide members of the public with education and awareness on public safety, while addressing areas of concern. Officers continue to provide a visible enforcement presence in the downtown core by foot and by vehicle patrol, which include alleys between businesses and common public gathering locations. In January, Peace Officers conducted eighty traffic initiatives resulting in thirty-eight traffic stops and thirty-seven tickets being issued. Patrols throughout the community parks, city facilities and neighborhoods, school and playground zones and businesses areas consisted of four hundred and one patrols. Peace Officers conducted two Joint Force Operations. One initiative with Commercial Vehicle Enforcement and one with the Military Police. Municipal Enforcement worked on ten animal related calls for service. Twenty-three seasonal related concerns were addressed throughout the community. Winter awareness and patrols relating to seasonal trends have continued.


## Energy Centre (School Year Start) Since September 2019

- Public interactions are regularly being made at the facility. Peace Officers continually liaise with school staff, students and city staff.

- Municipal Enforcement provides a visible presence at the facility, regularly during events.

- School zone safety and presentations continue to be conducted on regular basis.


## January 2020 - Calls For Service
