Bylaw No. 653-BD-19 - Procedure Bylaw Amendment for Indigenous Land Acknowledgment

Chief Administrative Officer K. Nagoya briefed Council on a proposed Procedure Bylaw amendment for Indigenous Land Acknowledgement noting that the following were included in the agenda package:

- Examples of Land Acknowledgements
- A Summary of the Final Report of the Truth and Reconciliation Commission of Canada (TRC)
- TRC Calls to Action
- 2017 Notice of Motion and Summary Report with Respect to Land Acknowledgement

Chief Administrative Officer K. Nagoya advised that this request was brought forth in 2017 and at that time, was defeated.

Former Councillor Darrell MacDonald, whom was seated in the gallery, was welcomed to the meeting. It was noted that he had spearheaded this same request in 2017.

After extensive discussions, all of Council expressed their full support in going forward with a Procedure Bylaw amendment which would include Indigenous Land Acknowledgement.
