#### SENIOR'S REBATE PROGRAM

#### 1.0 Purpose

Low income seniors are generally unable to augment their income to correspond with increases in taxes. This policy is designed to protect low income senior property owners from municipal tax increases.

#### 2.0 Policy Intent

The City of Cold Lake wishes to implement a program to protect low income senior property owners from municipal tax increase.

### 3.0 Policy Statement

The City of Cold Lake believes in fair and equitable application of the senior's Rebate Program. The base year for the seniors' tax rebate will be 2006. Seniors may annually apply for the seniors' tax rebate program on their principle residence only and must be eligible for the Alberta Government Seniors Monthly Cash Benefit Program to qualify. Eligible Senior's will qualify for a rebate on the portion of Municipal taxes greater than the amount taxed in 2006 to a maximum of \$250.00. The Seniors Rebate Policy will be reviewed annually prior to May 31.

# 4.0 Managerial Guidelines

The following are the requirements of the program:

- 1. The Senior's tax rebate will apply to the applicants' principle address only in the jurisdiction of the City of Cold Lake
- 2. The applicant must be a resident of the City of Cold Lake
- 3. The Senior's Rebate Program application should be made to Cold Lake Family and Community Support Services (FCSS)
- 4. Applications must be made prior to September 1 of the tax year applied for

- 5. The applicant must provide evidence that they are eligible for the Alberta Government Seniors Monthly Cash Benefit Program to administrative staff at Cold Lake Family and Community Support Services (FCSS)
- 6. The approved application will be forwarded to Corporate Service for processing
- 7. Rebates less than \$5.00 will not be made.
- 8. To those senior's who qualify, a rebate will be issued in the form of a cheque.
