

Items of Interest

- Municipal Enforcement had one Community Peace Officer successfully complete Radar and Lidar training.
- Municipal Enforcement addressed an ongoing trespassing concern at the Cold Lake Transfer Station. Additional charges were laid while reinforcing a previous ban. This area continues to be a facility of focus for the department.
- Officers intervened with an intoxicated male throwing objects and wandering into traffic. The subject was detained and lodged at the Cold Lake RCMP detachment until in a sober state and able to care for self.
- Municipal Enforcement provided scene and traffic control for an RCMP incident in Cold Lake south.
- Municipal Enforcement continues to address ongoing homelessness issues throughout Cold Lake. Many temporary structures continue to be dismantled and persons removed from the area. Regular patrols of the downtown core and frequented locations are being monitored by the team and RCMP. These areas are treated as hot spot patrol locations.
- Municipal Enforcement assisted with traffic control for a motor vehicle collision involving a school bus and SUV at the request of the RCMP.
- Municipal Enforcement assisted with traffic control at the request of the RCMP for the Veterans motorcycle ride. Visibility and presence were maintained throughout the event.
- Officers addressed ongoing unsightly property concerns at a Cold Lake residence. Municipal Enforcement worked with various partnering departments and agencies on the file. Efforts are ongoing at this time.
- Officers and the Parks team monitored overhanging tree concerns for summer preparation.
- Municipal Enforcement investigated storage of building materials and alleyway damage in Cold Lake north.

Municipal Enforcement continues to provide education and enforcement engagement throughout Cold Lake at high volume traffic areas. Various traffic initiatives included three speed sign deployments with one in the south, one in Tri-City and one in the north during the month of May. Municipal Enforcement continues to actively conduct patrols of the Transfer Station, marina, Energy Centre, public beaches, recreational areas, outdoor rinks and City facilities; with patrols consisting of three-hundred and sixty-one (361) patrols conducted in May. Officers provide an ongoing presence downtown by vehicle and foot patrols, which include alleys between businesses, common public gathering locations, green space areas, school zones and community neighborhoods; to which Officers conducted two-hundred and fifty-seven (257) patrols throughout the community in May. Peace Officers conducted seven Joint Force Operations; with the RCMP focusing on speed enforcement, distracted driving and school zone safety. Officers addressed twenty-eight (28) animal control calls and responded to two (2) dog bite incidents, investigated fifty-four (54) property standards complaints and addressed twenty-five (25) traffic and trailer parking issues.

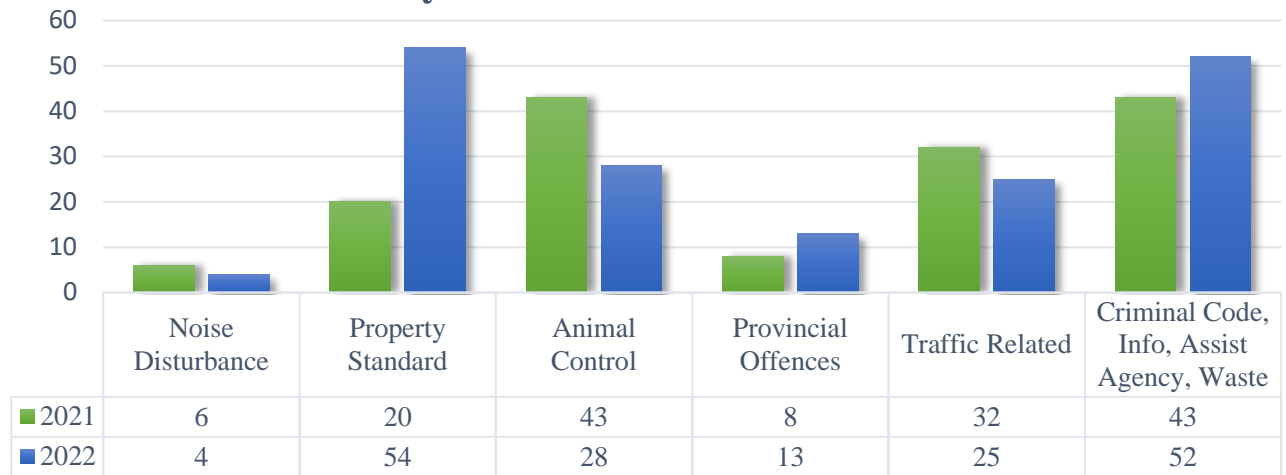
Bylaw Services Team (part-time Bylaw Officer team)

The Bylaw Officer team is currently down an Officer with minimum staffing per shift. Various concerns though were addressed under the program which entailed; thirty-eight (38) property standard files, six (6) animal control calls, seven (7) traffic issues and assisted with five (5) Provincial and criminal referral matters. Overall files consisted of twenty-seven (27) issues addressed, two (2) fines issued along with events consisting of four-hundred and fifty-one (451).

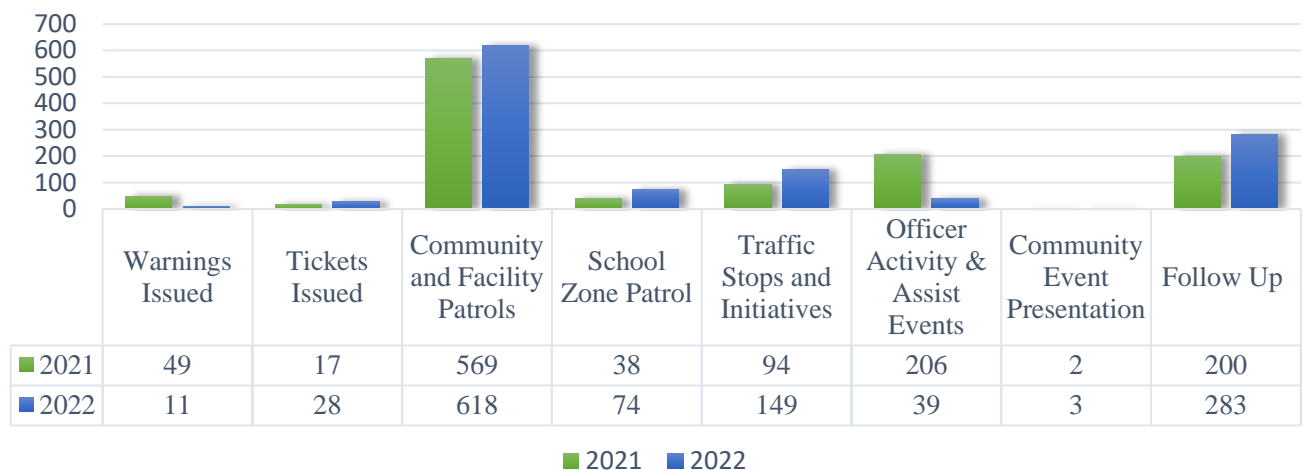
Energy Centre/Imperial Park/Facilities (School Year Start - September 2021)

Municipal Enforcement has conducted patrols of the facility and surrounding premises consisting of one hundred and fifty-two (152) in May. The team continues to work with RCMP on various criminal matters and suspicious activities at the facility and the Transfer Station. The Energy Centre and facility Peace Officer has issued sixteen (16) trespass bans since the school year commencement. The team has been busy working on identifying individuals involved in vandalism and trespassing at the Transfer Station. Officers continue to provide a visible patrol presence at the Energy Centre, facility grounds, parks and additional essential city facilities.
