

# STAFF REPORT

Title: 2023 Community Grant Advisory Committee - Winter Quarter Recommendations

Meeting Date: January 24, 2023

#### **Executive Summary:**

Council approved Policy No. 097-RC-07, being the Community Recreation, Art, Culture and Heritage Investment Grant Policy ("Policy") in March 2007. The intent of this Policy is to "provide occasional grant funding within the City of Cold Lake to assist with the development and enhancement of recreation, art, culture and heritage programming."

In September of 2020 the Policy underwent meaningful change resulting in a broadened scope and intake deadlines. The Policy now responds to the needs of the grant committee and community.

The purpose of this Staff Report is to present, for Council's consideration, the 2023 Winter Intake Recommendations of the Community Grant Advisory Committee ("CGAC") respecting eleven (11) grant applications and two (2) letters requesting sponsorship. These items were reviewed by CGAC on January 11, 2023.

The Council Goodwill budget for CGAC program is \$80,000 of which the CGAC is recommending \$14,876.18. The CGAC has recommended that approximately \$20,000 to \$25,000 to be referred to the spring intake as further information is required for those applications.

The CGAC is recommending that another \$34,000 be considered directly from Councils <u>\$20,000 Goodwill Budget</u>. It should noted that there is also \$6,000 of requests from this program under other agenda items (Totaling \$40,000 in requests). The Community Capital Grant Program has \$50,000 however this program of which applications are due by March 1, 2023 and funding announcements are made by April 30, 2023. We under that the request by the Cold Lake Music Festival Association is urgent.

# BACKGROUND:

Within the 2023 Operating Budget, Council allocated:

- \$80,000.00 to the Community Recreation, Art, Culture and Heritage Investment Grant program; and
- \$50,000.00 to the Community Capital Grant program.



Council set the following deadlines to apply for the Community Recreation, Art, Culture and Heritage Investment Grant program:

- Winter Deadline: 4:30 PM on the first Thursday in January.
- Spring Deadline: 4:30 PM on the first Thursday in April.
- Summer Deadline: 4:30 PM on the first Thursday in August.
- Fall Deadline: 4:30 PM on the first Thursday in October.

Administration reviewed the CGAC recommendations to Council regarding the eleven (11) grant applications and two (2) letters requesting sponsorship received at the Winter deadline.

# 1ST KINOSOO SCOUT GROUP

1st Kinosoo Scout Group is a youth and adult group that has operated within in Cold Lake for over 15 years. Members learn basic survival and first-aid skills, community service skills and how to work efficiently with others.

Administration Comments:	The Applicant is a registered Society through Scout Canada. Supporting documentation are included with the application.

# COLD LAKE MINOR HOCKEY ASSOCIATION

Cold Lake Minor Hockey Association operates a variety of hockey teams within the City of Cold Lake. One of those teams, the U18 Lakeland Jaguars women's hockey team, is



once again hosting the U18 Female Provincial Championships from March 30 to April 2, 2023.

Funding Request:	Community Incentive Grant in the amount of \$4,761.
Purpose of Request:	Host the U18 Female Provincial Championships from March 30 to April 2, 2023.
Allowable Funding:	Up to a maximum of \$10,000 per organization, per event each calendar year.
Prior Funding:	2018 - Travel Grant \$1,000 2019 - Other Funding and Goodwill Grant - \$5,000 2022 - Community Incentive Grant \$5,000; 2022 U18 Female Provincial Championships
Administration Comments:	The Applicant is a registered Alberta Society. Supporting documentation is included with the application.

Purpose of Request:	To assist with costs associated with hosting the 2023 Music Festival (including videographer, piano tuning, adjudicators, advertising, awards and medals) from March 20 to April 13, 2023.
Allowable Funding:	Up to a maximum of \$1,500 for an outcome-based program and/or a maximum \$3,000 per organization per calendar year.
Prior Funding:	2018 – Council Goodwill \$1,000. 2022 - Arts, Culture and Heritage Grant \$1,500; 2022 Music Festival.



Administration Comments: This is application 1 of 2 for the Winter Intake. The Applicant is a registered Alberta Society Supporting documentation is included with the application.

CGAC Recommendation: Moved by Michelle Myers that the application by Cold Lake Music Festival Association be accepted, and to make a recommendation to Council for funding approval in the amount of \$1,500 for an Arts, Culture, and Heritage Grant in support of hosting the 2023 Music Festival. The Cold Lake Tennis Club is a community group that aims to increase the awareness of the sport of tennis in the City of Cold Lake, and encourage all forms of tennis participation.

Funding Request:	Development Incentive Grant in the amount of \$2,175.
Purpose of Request:	To assist with costs associated with attending a Tennis Instructor Course held by Tennis Alberta.
Allowable Funding:	Up to a maximum of \$2,500 per year, per event, per calendar year.
Prior Funding:	2021 - Development Incentive Grant; \$2,500. 2021 – Equipment Grant; \$2,500.
Administration Comments:	The Applicant is a registered Alberta Society. Letter of Support outstanding. The request falls within the parameters of the Leadership Grant.
CGAC Recommendation:	Moved by Lacey Chyz that the application by Cold Lake Tennis Club be accepted, and to make a recommendation to Council for funding approval in the amount of \$1,087.50 for a 50:50 matching Leadership Grant in support of tennis instructor training held in Edmonton and Calgary. ( <i>CARRIED</i> <i>UNANIMOUSLY</i> )

Allowable Funding:	Up to a maximum of \$500 per individual per calendar year or up to a maximum grant of \$1,000 per team per year.

Administration Comments:	Applicant is not a registered society. Application and supporting documentation were not received, as required by the Policy.
CGAC Recommendation:	Moved by Councillor Ryan Bailey that the letter submitted by Keith Bateman requesting sponsorship for the Lakeland U16

#### TITANS BOXING CLUB INC.

Titans Boxing Club Inc. is a for-profit organization that provides training and direction in the sport of boxing by creating a healthy environment that builds self-esteem and character through structured and disciplined training.

Purpose of Funding:	Assistance with rental costs in hosting a community boxing event on March 4, 2023. Those costs include Energy Centre facility rental fees, dressing rooms, chairs, and chairs, bar service, booth and fridges, and tickets.
Prior Funding	2022 - Other Funding or Goodwill Grant \$3,812.31
Allowable Funding:	Where a major event with a budget greater than \$100,000, up to a maximum of \$20,000 per event. Annual or regularly occurring events will be eligible.
Administration Comments:	The Applicant is a registered Alberta Business. Required supporting documentation was not included.
