NOTICE OF MOTION

I, Councillor Vicky Lefebvre, am putting forward this "Notice of Motion" so that Council may consider the matter contained herein during its August 22, 2023, Regular Meeting of Council. This Notice of Motion requests that administration draft, for Council's consideration, options to either restructure the Community Grant Advisory Committee such that grant applications are decided by a "Committee of the Whole of Council," or to dissolve the Cold Lake Community Grant Advisory Committee, so that all grants are considered directly by City Council during a Regular Meeting of Council.

"That Council direct administration to bring forward, for Council's consideration at its August 22, 2023 Regular Meeting of Council, amendments to the necessary bylaws and policies that would ensure applications made for grants funded by the City of Cold Lake will be considered by all members of Council, whether sitting as members of a committee, or during Regular Meetings of Council; and that meetings during which grant applications may be considered be held on a monthly basis, excepting the summer months."

BACKGROUND

The mandate of the Cold Lake Community Grant Advisory Committee is to review funding requests that address a community service need and make recommendation to Council for funding which aligns with established grant and sponsorship programs, within the budgeted allocations for the programs.

Understanding that the final decision for grant allocations would be by Council, in its sole discretion, Council has increasingly been inconsistent with its expectations in regards to the Community Recreation, Art, Culture and Heritage Grant Program. The following provides a summary of concerns:

- 1) The implementation of the Community Grant Advisory Committee appears to be more political than administrative:
 - a) Council has made some organizations follow criteria while others have not been required to. In fact, some approvals have been made for organizations that have provided minimal information and/or not even a formal application. This approach isn't equitable.
 - b) There are now an increasing number of requests that seek to circumvent the Community Grant Advisory Process and appeal directly to Council for a decision.
 - c) Council has repeatedly changed the amount of funding being provided. The rationale seems to be entire political.
 - d) The funds being approved by Council and the recommendations being made by the advisory committee are significantly over budget. There have been times that the committee has made recommendations to provide more funding that was requested by organizations, despite being over budget. It should be noted that the committee's mandate does not allow it to exceed the budget for a program. This is happening despite that fact that the program specifically states "....aligns with established grant and sponsorship programs, within the budgeted allocations for the programs."

The above makes it very difficult to administer program and understand Council's expectations in regards to making recommendations. In essence, Council seems to be inconsistent with its expectations. It is not fair to ask that volunteers make difficult funding decisions in the absence of clear direction and a firm mandate. If the current situation is to continue, the community's elected officials should shoulder the responsibility of making these funding decisions, whether by meeting as a Committee or through decisions at a Regular Meeting of Council.

- 2) In the past 24 months, the City of Cold Lake has seen a tremendous increase in the volume of requests for financial assistance from charities, not-for-profit groups, and community social service organizations as well as a significant increase in the amount of funding the average request is for. It is anticipated that this trend will continue and therefore the opportunity for application intakes and the frequency with which meetings for grant applications should also be increased. The frequency of the formal regular committee meetings should be increase to monthly.
- 3) Council should have a discussion regarding as to what extent our taxpayers benefit from the service provided by charitable donations made by the City of Cold Lake, and how generous we as Council should be. Should Council continue to levy property taxes with the purpose of using an increasing portion of the revenue to grant to organizations and individuals, or should this money be left with the taxpayer so that the taxpayer can make their own decisions regarding its use, whether that use be charitable or not? Remembering the principle that there is only one taxpayer, council should be aware that there is a burden created by Council's generosity that is ultimately shouldered by the residents and businesses who pay property taxes in our jurisdiction.

The attached tables provides a summary of decisions made from Council's Goodwill, inclusive of the Community Recreation, Art, Culture and Heritage Grant Program, which is part of the Council Goodwill.
