Title: Bylaw No. 794-BD-23 - Bylaw to Amend Cold Lake and District FCSS Advisory Committee Bylaw No. 509-BD-14

Executive Summary:

Bylaw No. 509-BD-14, Cold Lake & District Family & Community Support Services Advisory Committee Bylaw establishes a Committee whose mandate includes, *but not limited to*:

- acting as an advisor to Council with respect to social service-based programs, services and facilities;
- seeking out and applying for funding that allows the Committee to address the social needs of the Community; and
- recommend guidelines and polices for the long-term planning of the social infrastructure of the community.

The FCSS Advisory Committee undertakes review of Bylaw No. 509-BD-14 where meaningful changes may occur to core services. Administration has prepared a Bylaw amendment to FCSS Advisory Committee Bylaw No. 509-BD-14 as part of regular housekeeping, and presents Council with the opportunity to ensure Administration aligns with Council's expectations.

FCSS Advisory Committee Bylaw No. 509-BD-14 was passed on August 14, 2014 and has since been amended from time-to-time. The purpose of the amendment presented for Council's consideration is to broaden FCSS mandate respecting review and recommending approval for grant programs approved by Council.
