## CITY OF COLD LAKE BYLAW 796 -LU-23 A BYLAW TO AMEND LAND USE BYLAW NO. 766-LU-23

A BYLAW OF THE CITY OF COLD LAKE IN THE PROVINCE OF ALBERTA, TO AMEND LAND USE BYLAW NO. 766-LU-23 BY REZONING PLAN 1221080 BLOCK 1 LOTS 38, 39, 40, and 41 FROM R1A-RESIDENTIAL (SINGLE DETACHED) DISTRICT TO R3-MEDIUM DENSITY RESIDENTIAL DISTRICT

**PURSUANT** to sections 640 (1) and 640 (2) of the *Municipal Government Act*, RSA 2000, Chapter M-26, a council must adopt a land use bylaw which divides the municipality into districts which prescribe the use(s) of land and buildings within said districts; and pursuant to section 191 (1) of the *Municipal Government Act*, RSA 2000, Chapter M-26 as amended, Council may pass, amend or repeal a bylaw;

WHEREAS the City of Cold Lake Land Use Bylaw 766-LU-23 was passed by Council on March 3, 2023;

**WHEREAS** Council deems it necessary to rezone the lands described as Plan 1221080 Block 1 Lots 38, 39, 40, and 41 from R1A-Residential (Single Detached) District to R3-Medium Density Residential (Row Housing);

**NOW THEREFORE** the Council of the City of Cold Lake in the Province of Alberta, in Council duly assembled, hereby enacts as follows:

## **SECTION 1 – TITLE**

1. This Bylaw shall be cited as the "Bylaw to rezone Plan 1221080 Block 1 Lots 38, 39, 40, and 41 from R1A-Residential (Single Detached) to R3-Medium Density Residential (Row Housing)".

## **SECTION 2 – REZONING APPROVAL**

- 2. The City of Cold Lake Land Use Bylaw 766-LU-23 is hereby amended by:
  - 2.1 The approval of the rezoning of Plan 1221080 Block 1 Lots 38, 39, 40, and 41 attached to and forming part of this bylaw as Schedule 'A' from R1A-Residential (Single Detached) to R3-Medium Density Residential (Row Housing).

## **SECTION 3 – ENACTMENT**

3. This Bylaw shall come into full force and effect at the beginning of the day that it is passed.
