- 6. Describe the ask for support: We are a locally military owned/operated martial arts club within the boundaries of Cold Lake asking for support from the City of Cold Lake to host the cities first Brazilian Jiu Jitsu tournament. This tournament is open to competitors both youth and adult Canada-wide. We are hoping to acquire funds to help with the costs of this tournament, as will be outlined further.
- 7. Describe the targeted audience, expected attendance, or membership: Our target audience/athletes are ages 6yrs to adult from Western Canada specifically, but not limited to. We also recognize that along with athletes competing will be their families/support system in attendance, as this is a family-friendly event. Our attendance is expected to be 250 athletes PLUS their families/support system.
- 8. Describe how these funds will develop or enhance recreation, art, culture, and heritage

within the city: These funds will help to bring more awareness to Cold Lake and surrounding communities by bringing athletes and their families/support system into our beautiful northern lakeside city. It is our hope that spectators will gain more insight and interest in combative sports in our area and see the many positive effects on both physical and mental health they provide.

- 9. Identify all other fundraising strategies and requests: Our tournament is based on paid registration for the event through Smoothcomp (online registration software) plus on-site merchandise sales the day-of.
- 10. Describe how you will acknowledge the City of Cold Lake as a sponsor: The City of Cold Lake will be acknowledged as a sponsor via online marketing through our social media sites and sponsored posts online, including the city logo.
- 11. Provide details of any locally sourced items, resources, or services: We have secured a local photographer, DJ, foodtrucks, and medical

personnel for the day. Due to the timing of our tournament, 8am - 3pm, we recognize that most athletes and their families/support system will be staying locally in hotels overnight (or the entire weekend), frequenting our local restaurants and enjoying the services/outdoor areas our city provides.

- 6. TV's x3 (at each station to showcase points/scoring and athletes names) \$800
- 7. Laptops x3 (to run brackets) \$850
- 8. New Logo Design for tournament Fiverr \$120
- 9. Custom Tournament Medals \$1375
- 10. Referees -- 6ppl @ \$125/ea \$750
- 11. Smoothcomp Fees undetermined at this time, as it's calculated per person/registration
