### **Executive Summary:**

Kempe Fitness and Fighting Owners/Operators Bernie and Debra Antle appeared as a delegation earlier on tonight's agenda.

The organization is looking to host a Brazilian Jiu Jitsu Tournament on Saturday October 14, 2023.

### **Background:**

Further to correspondence dated August 16, 2023, the organization has requested to increase their request for financial assistance from \$5,000 to \$6,200. Based on the submission Bernie and Debra Antle are requesting for financial assistance for costs and equipment that include the following:

- Live DJ Costs Area 51 Entertainment \$750
- Professional Photographer Costs local photographer & Kempe member Arturo Pena \$500
- Senior's Society Hall Rental Cost \$400
- Marketing Materials (banners, etc.) Vistaprint \$400
- TV's x3 (at each station to showcase points/scoring and athletes names) \$800
- Laptops x3 (to run brackets) \$850
- New Logo Design for tournament Fiverr \$120
- Custom Tournament Medals \$1375
- Referees -- 6ppl @ \$125/ea \$750
