6. We are requesting financial support to assist in covering expenses that are incurred to provide the community with a free day of fun. In the past activities at these events included: bouncy castles, clowns, balloon animals, petting zoos, horse rides, wagon rides, live bands for dancing and entertainment, and family games (such as corn hole, golfing, rope toss).

Other costs associated with the event include wash cars as the halls septic system cannot withstand the large volume of attendees, hall cleaners, generator rentals for yard activities.

7. This is an event that we aim to target all audiences. Each year we have had all genders and ages attend from newborn to late 90s. Families and friends, all join where there are options for all ages.

Each has had close to 1000 attendees each year and are expecting the same for this year's event.

8. The funds will be utilized to help Riverhurst be able to grow and continue our event to ensure a free recreational event for all community members. This year the event will be hosting a quilting show in doors of the hall during the outdoor event which highlights the arts in the community as well as the outdoor event is providing space for local vendors to highlight and sell their work.

In respect to heritage...the Riverhurst Community Hall has been around since 1949 providing a space for community events and highlighting the importance of family and community. At these past events we have had community members in their 90s sharing stories with younger generations of what this hall means.

9. In addition to requesting support from the City of Cold Lake, the Riverhurst Community Hall has reached out to local companies to provide sponsorship. We have been provided with \$1500 from local businesses.

The Hall will be utilizing our own funds for the remainder of the event.

- 10. We can effer acknowledgment on our social media page (facebook with over 1,400 followers), digital sign on Hwy 55, and at the event multiple times throughout the event. We can also hang provided banners or signs and hang them up at the event.
- 11. All entertainment and events are sourced locally and support local business. We utilize a local band, Puddy's Canteen, for the dancing and music entertainment. Each year we highlight the Cold Lake cruisers and provide them with an area to promote their club. We have supported local businesses for entertainment and games such as: 350Farms, The Wolf Pack, Penners Ranch, and Cowboy Town. We invite all local food trucks to come out and offer goods for those who would like to purchase snacks and funch including Tim Hortons, Joly's Frozen Desserts, Pour House & Grill, Stems and Flappers, Marvelous Minis, and Dobbin's Cold Lake. In addition, our beer grounds are 100% local with Cold Lake Brewing and Distilling.
