## **COUNCIL COMMITMENTS (CONFERENCES)**

The following are some examples of Conferences that are attended by various elected officials throughout the province. Please note that this is not an all inclusive list.

Attendance to any conference are neither mandatory or promoted with the exception for a few. You'll see that, subject to policy and budget, an elected official could be on the road for the most of their term.

1. <u>Alberta Professional Planners Institute</u> - Annual National Conference - Typically held in July.

This year the conference is being held in Edmonton between July 9 – July 11, 2024

 Alberta Library Conference – The Alberta Library Conference (ALC) is Alberta's largest provincial library conference, hosted annually by the Library Association of Alberta (LAA) and the Alberta Library Trustees Association (ALTA). 

## **COUNCIL COMMITMENTS (CONFERENCES)**

The following are some examples of Conferences that are attended by various elected officials throughout the province. Please note that this is not an all inclusive list.

Attendance to any conference are neither mandatory or promoted with the exception for a few. You'll see that, subject to policy and budget, an elected official could be on the road for the most of their term.

1. <u>Alberta Professional Planners Institute</u> - Annual National Conference - Typically held in July.

This year the conference is being held in Edmonton between July 9 – July 11, 2024

2. <u>Alberta Library Conference</u> – The Alberta Library Conference (ALC) is Alberta's largest provincial library conference, hosted annually by the Library Association of Alberta (LAA) and the Alberta Library Trustees Association (ALTA). This year the caucus for the Lakeland area is meeting on June 13, 2024 in Bonnyville. There are four other locations throughout Alberta.

7. <u>Federation of Canadian Municipalities Conferences (ANNUAL)</u> – Join more than 1,000 elected officials from coast to coast to coast for Redefining our future, FCM's 2024 Annual Conference and Trade Show and Canada's largest pan-Canadian gathering of elected officials.
