A BYLAW TO AMEND BYLAW NO. 755-PL-22
ANIMAL CARE AND CONTROL BYLAW

PURSUANT to Section 63(1) of the *Municipal Government Act*, RSA 2000, Chapter M-26, as amended, a council may by bylaw authorize the revision of a bylaw of the municipality;

WHEREAS Council passed Bylaw No. 755-PL-22, Animal Care and Control Bylaw on August 23, 2022 to regulate the care and control of animals in the City of Cold Lake;

WHEREAS Schedule “A” and Schedule “B” of the City of Cold Lake Bylaw No. 755-PL-22 sets out fee for Animal Licensing;

WHEREAS Council would like to amend Schedule “A” and Schedule “B” of Bylaw No. 755-PL-22, Animal Care and Control Bylaw;

NOW THEREFORE the Council of the City of Cold Lake in the Province of Alberta, in Council duly assembled, hereby enacts as follows:

SECTION 1 - TITLE

1. This Bylaw shall be cited as the "Amendment to Bylaw No. 755-PL-22, Animal Care and Control Bylaw, License Fees."

SECTION 2 - BYLAW AMENDMENT

2. Schedule “A” and Schedule “B” of Bylaw No. 755-PL-22 is hereby replaced with the attached Schedules to this Bylaw.

SECTION 3 - ENACTMENT

3. This Bylaw shall come into full force and effect at the beginning of the day on which it receives third and final reading.
